Remember the days when all our road rides, five in total, were organized and run throughout the summer riding season? Such was the event in the picture above—the 2005 Economy Run. These days we're lucky to complete two, maybe three road rides, towards the road riding championship. Three of the events, for the past several years, had repeat organizers which we're grateful for, but, in the past, asking our membership of 500 to step up and organize the others has been futile.

This year two of the organizers will be laying out their repeat event but the third will not be here so it will be one of the events we have to ask for someone else to do. By the time of posting this newsletter one of the "repeat" events has been run.

The Paper Chase, started in 1948 and the Century Run which began in 1947, are our two oldest recorded road rides. The Nuts in May, and the Mt. Baker Road Ride, began in the 70's and were created by former member **Dave Shepherd** (RIP), who also with his "Geritol One" group, started two cross country enduros - the Team and Equalizer enduros. **Shepherd** also resurrected the Poker Run Road Ride in the 70's. The Economy Run was started in 1994 by **Dave Moore**.

Will we be successful in running all our road rides this year? - it's hard to



know but it's all up to the membership. A little time and effort goes a long way—**volunteer now!**

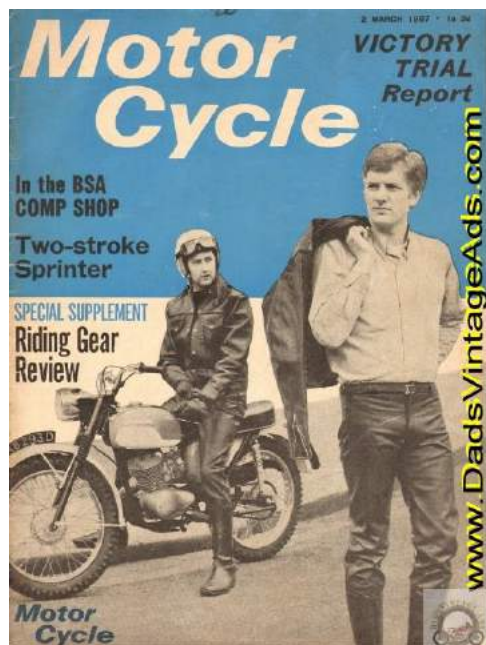

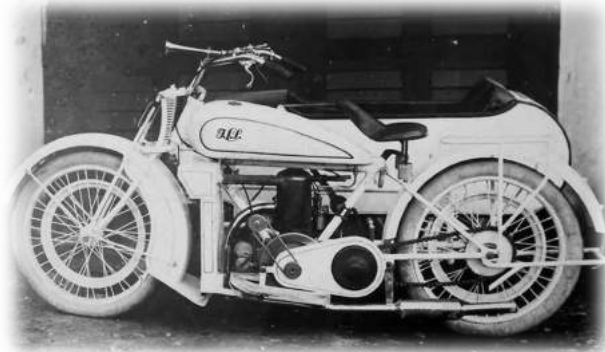

Some models had their own a 555cc water-cooled single-cylinder 2-stroke engine, balloon tires and, on later models, a saddle tank. They used rim brakes until 1929. Lechner also built models with 300 to 1000cc JAP engines, the larger model having a Sturmey Archer gearbox.

Minutes of the Regular Meeting - Held on May 17, 2022, upstairs at Barnes Harley-Davidson Victoria. With 20 Voting Members present plus 6 New Member Applicants and 8 Returning Member Candidates in Attendance: In Attendance – President: **Dave Horner**, Vice President: **Mark Fisher**, Treasurer: **Perry Chow**, Secretary: **Peter Grant**, Directors: **Andy James**, **Brent Donaldson**, **Dave Fair**, **Dave McCullough**, **Tony Wilson** Membership Chair **Rick Kool** absent; directors **Nick Newton** (work conflict)

## Welcome

The meeting was called to order by the President, **Dave Horner**, at 7:28 PM. This is the third Regular Meeting to be held since February 2020, due to Covid19 Pandemic health restrictions. The minutes of the previous Regular Meeting held April 19, 2022, were read by **Sec Grant**. **Roger Boothroyd** moved the minutes be adopted as read, seconded by **Brent Roler** and Carried.

## Business arising from the Minutes /Outstanding or Old Business

### 1) Treasurer's Report - as at May 1, 2022

**Perry Chow**: presented the Treasurers Report.

- Current budget and financial report were presented
- Income has been received from three Trials events and two **Sam King's** riding schools

**Perry** presented a concern he has regarding fund raising for the Property Acquisition Fund, in particular regarding fundraising through sale of shares or debentures. Nothing further was said at that time.

- A Motion to accept the Treasurers Report was made by **Roger Boothroyd**, Seconded by **Rob Beecroft** and Moved.

2) **Dave Horner**: updated membership on status of drawings to be submitted for building permit for the new 24' x 36' Pavilion to replace the clubhouse shack lost by fire.

Drawings are expected to be completed any day, he will follow up.

3) **Dave Horner**; on the Extra-Ordinary Motion for supply of Electrical Power to Cycle Park:

Motion to allow expenditure of \$25K for BC Hydro to install Powerline, Pole and Transformer to the property plus additional \$10K for construction of Power Shed with service panel and other requirements.

- Internal distribution and if approved a Powered Gate will increase the total expenditure by possibly as much as \$15K.

- **Brad Adams** estimates the total cost will approach \$50K. **Dave** suggested with members providing their expertise and labour and supply of much of the material there are savings available.

- Motion was put to a vote with 19 eligible voting members in favour. Approved.

4) **Dave Horner**; requested the club waive charge of \$150 for a quantity of milled lumber that was used for construction of a small deck on the new home of Life Member **Terry Hyde**. No objections were raised.

5) **Dave Horner**; on Trail Maintenance:

- Looking for a volunteer to spearhead a committee to oversee and organize work parties to complete periodic repairs and upkeep of internal riding trails at Cycle Park

- **Dave** suggested member **Mike Hornick** is interested. Tabled for further discussion.

- Mini-Excavator's may be available from member **Chris Hall** and Coast Guard.

- Reported that member **Paul Gronow** has taken on the task of creating a Trail Map and Signage to be erected for the internal trails at Cycle Park.



**6) Dave Horner; Club Website:**

indicated that he will connect **Lillian Wilbur** and **Ian Burton** to review what is needed to construct of a more user friendly, modern website.

**7) Dave Horner; Updated membership on the new Mosaic Forestry Trail Access Committee.**

- first meeting of the committee members was last week.
- **Brent Donaldson** will act as Committee Chair.
- A move-forward process has been roughed out.
- Initial request will be to gain access for VMC to host a Dual-Sport event for road legal bikes on Mosaic lands. Long term goals include permanent access to trails for non Road Legal bikes and to become a Steward of specific Mosaic land tracts.

**8) Dave Horner and Brent Donaldson; Updated on Hill Climb event.**

- **Brent** provided a historical background
- Call for a new volunteer Chairperson the Hill Climb committee. No one stepped forward.

**9) The following roles and areas of responsibility were raised:**

- **Mark Fisher** - will continue to oversee general upkeep of Cycle Park's lower parking area. o He will have new load of crushed stone spread as needed
- + will bring logs in to the far end to block off truck parking where we are building a Small Tykes riding area.

**Dave Fair** continues to oversee Trials.

+ **Dave Fair** provided update on the five Trials events scheduled for 2022.

- **Lillian Wilbur** is ongoing as Trophy Committee Chair.
- **Roger Boothroyd** continues as Newsletter Editor and recently named Director of Communication.
- **Call for Volunteers** to Chair organizing committees for these event committees and club functions: o Dual-Sport, b) Road Rides, c) Hare Scrambles/Enduro (and Hillclimb as above)
- o Trail Maintenance work parties at Cycle Park
