

V8Z 7H5 reated by members **Ben Hircock** and **Dave McCullough**, the picture on the front page is an aerial view of Cycle Park, the property owned by the Victoria Motorcycle Club. The 160 acres on the mountainside, was purchased in 1962 and was land locked with access only by the generosity of a neighbour. However, there were no houses up top so riders were able to use a lot of that property for events and to make their way to the Sooke Road and beyond. We are now totally surrounded by housing with no access to that "beyond."

The second purchase of the adjacent 12 acres was purchased in 1968 and allowed members private access to the whole 172 acres. Since purchasing, the club has shared a short section of the neighbour's driveway where it crossed the CNR track (now Galloping Goose Trail.) In the early years, the club had to pay a fee to the CNR for the right to cross the tracks but that was eventually eliminated when the tracks were taken up.

The map shows approximate main trail locations. Several trails are difficult and none are rated by any formal system, some leading to steep cliffs or other hazards. Riders must use their own discretion as to their own abilities to determine which trails (if any) to ride. There are also many, many trails not shown on this map. Always ride with a buddy and never ride without someone having knowledge of the area before you are comfortable with knowing your own abilities and how to navigate the VMC property. All riders ride at their own risk.



Many, many hours and even days of volunteer work have been put in to build and maintain this riding oasis with, this year, a new pavilion being erected to replace the old club house that burned in December 2021.

Using lumber milled on our property, member **Mike Hornick** has been the lead on this project. When finished it will be the shelter for event sign up and to keep out of the rain (?). We thank **Mike** and all other volunteers for the many hours of work that has taken place.

Aside from now being one of the entrance requirements, volunteering some time is educational, often good fitness, and a fun way to become more a part of this club that we all enjoy. Volunteering to help on one of the events is the best way to get to know people and to help make a good name for yourself, along with making the event a success. 
A Brief History of the Marque Mitchell

50cc four-cylinder two-stroke built by Duncan Mitchell of Moto Decla, Stevenage, in the early 1960s. The engine was designed by Eric Fitz-Hugh some years earlier and further developed by Mitchel, an experienced 50cc frame constructor, who also built a 5 speed gearbox for the machine. With a bore and stroke of 25.3 x 25mm, each cylinder has a capacity of 12cc. The machine was not completed due, it is said, to financial constrictions. It now resides in **Sammy Miller's** Museum.

the dynamics of helicopter design. Sikorsky went on to be a huge innovator in

helicopters, producing the first operable American helicopter in 1939. In 1913 Anzani had seven different aircraft engines available, one of which was a two-row 10 cylinder radial. in 1906 he built a motorcycle with a propeller.

The bike here was specially designed to create a large slipstream for its rider and is equipped with what was then a powerful v-twin motor.

I find that interesting as the cylindrical copper fuel/oil tank looks pretty uncomfortable with its flat end. If the rider was to lay down upon it while racing, it seems as if it would hurt. If the "slipstream" is at the end of the tank,

the rider seems to have had to crunch into a fetal position to race this bike. See where the handlebars stretch back to the end of the tank? That seems to have been the concept. Were there chiropractors in 1925? Ed.

WELCOME:- The meeting, 'al fresco' (open air) was called to order by the President Dave Horner at 7:29 PM.

- 1) Sec. Grant read the minutes of the previous Regular Monthly Meeting of 05/16/23.
- Roger Boothroyd moved the minutes be adopted as read, seconded by Justin Roach, Carried.
- 2) Sec. Grant read the minutes of the prior weeks Executive Monthly Meeting of 06/15/23.

- 'Property Boundary Respect our Neighbors'. If you see this sign you are getting to close.
- 5) Dir. Brent Donaldson provided an update on three (3) New Member Orientation Sessions held in May with 35 (of 46) new members attending.
- Eleven new members still to go through Orientation session to become qualified to receive a Gate Key.
- Brent will schedule two more sessions, dates TBD in July.
- 6) Dir. **Brent Donaldson** requested a Call for Volunteers;
- to assist operating a BBQ to provide a sponsored lunch for the Trials de Nations 'Fundraiser Trials Schools' scheduled for July 8th & 9th.
- 7) Pres. Horner called on Dir. Mike Hornick to provide an update on the Memorial Pavilion construction.
- Initial concrete works completed; forms stripped. Backfilling almost complete.
- Posts stained and ready to be erected. Hardy-Panel to be ordered, 'Blue & White'.
- Electrical Power Shed concrete slab poured and framing up.
- Ready for trenching for conduit for power, water and comm's to pavilion.
- 8) Pres. Horner provided a brief update on the delay on BC Hydro's installation due to legal issue.
- Lawyers were to have completed the correction this week. **Dave** will contact **Murray Anderson**.
- update on the Powered Gate project dependent on BC Hydro project.
